Colorado PERA invests retirement and Health Care Trust Fund assets for the sole benefit of the Plan's members. State law gives responsibility for the investment of PERA's funds to the PERA Board of Trustees. The Board approves the Colorado PERA Statement of Investment Policy and determines the strategic asset allocation policy. PERA believes that the most effective and efficient long-term strategy is to invest in a broad array of asset classes.
